A RESOLUTION DECLARING CASTLE ROO CAR SERVICES AS THE SINGLE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE REPAIR OF HYUNDAI DAEYANG FIRE TRUCK OF BAROTAC VIEJO FIRE STATION, PROVINCE OF ILOILO AND RECOMMENDING TO THE REGIONAL DIRECTOR, BFP REGION 6 THE AWARD OF CONTRACT

WHEREAS, pursuant to Regional Order Nos. AMD-2020-11-24, DSG-2021-03-30 and DSG 2021-05-12 dated November 19, 2020, March 23, 2021 and May 06, 2021 respectively, the Regional Bids and Awards Committee (RBAC) was reconstituted. It was created and has been reconstituted to promote transparency and economy and to recommend the award of contracts and purchases to the head of procuring entity or his/her duly authorized representative as stipulated under Section 11 and 12 of R.A. 9184;

WHEREAS, there is an approved budget amounting to **Eight Hundred Eighty-One Thousand Nine Hundred Twelve Pesos (PhP 881,912.00)** intended for the **Repair of Hyundai Daeyang Fire Truck of Barotac Viejo Fire Station, Province of Iloilo**;

WHEREAS, the Regional Bids and Awards Committee (RBAC)-BFP Region 6 invited interested suppliers or the aforementioned procurement opportunity by posting the same at the PhilGEPS website, BFP Region 6 website and at conspicuous places within the premises of the BFP Regional Office 6 on May 25 to June 4, 2021;


WHEREAS, there is only One (1) interested supplier who submitted bid documents before the deadline of submission on June 4, 2021 at 9:00 O'clock in the morning;


WHEREAS, the RBAC convened on June 4, 2021 at 9:30 in the morning for the preliminary examination and evaluation of documents submitted by responding supplier;


WHEREAS, the BAC proceeded with the evaluation of the legal and technical documents submitted by Castle Roo Car Services (Castle Roo for brevity). Upon examination, evaluation and verification of the documents, it was noted to have complied with all requirements. The RBAC then resolved to declare Castle Roo as "eligible" with financial offer amounting to **Eight Hundred Eighty-One Thousand Six Hundred Twelve Pesos (PhP 881,612.00)** and was declared as the Single Lowest Calculated Bid for the aforementioned procurement upon resolution of the motion raised by **CINSP ALAN G GATUNGAY** which was duly seconded by **INSP JASMIN C MECENAS**;

NOW THEREFORE, upon the motion of **CINSP ALAN G GATUNGAY** duly seconded by **INSP JASMIN C MECENAS**, we, the members of the BFP6 Regional Bids and Awards Committee (RBAC), hereby **RESOLVE** as it is hereby **RESOLVED**, to declare Castle Roo Car Services as the Single Lowest Calculated and Responsive Bidder for the Repair of Hyundai Daeyang Fire Truck of Barotac Viejo Fire Station, Province of Iloilo and recommend to **SR SUPT JERRY D CANDIDO (DSC)**, Regional Director, Bureau of Fire Protection, Region 6, the award of the contract, for his approval.
